My inclusion on your electoral roll was made without full disclosure, understanding, or my informed consent regarding the consequences, jurisdiction, and implications under admiralty/statutory law. As such, I consider my continued enrolment unlawful and in violation of my inherent right to self-determination and governance by tikanga.

I assert the following:

- I am governed by tikanga, not statutes.
- I am a living being, not a corporate entity.
- I am enrolled with the Sovereign Crown of the Mauri Nation Electoral Roll, under divine law, tikanga, whakapapa, and spiritual jurisdiction.

Please remove my name from all records and cease and desist from any further attempts to contact me regarding political participation under foreign jurisdiction.

This is my lawful and spiritual position. It is final and irrevocable.
